Foreword

Commissioning as per DIN-VDE 0100-600 is a key element of the specialist tests "Operating technology electronics engineers" and "Mechatronic technicians".

However, this is not limited solely to the practical execution of the tests. Trainees must also prove knowledge of the relevant theoretical background knowledge during the tests. The following questions can be seen as a "formula" for test preparation:

Why is testing carried out?

How is the system prepared for the test?

How is the test device prepared for the test?

Which test results are considered OK for the system?

The purpose of working through the tasks, in addition to acquiring practical knowledge of the test process, is also to verify that the trainee is familiar with all of the essential technical background information.

Remember that tests under DIN VDE 0100-600 must be carried out by qualified electricians (with test experience). Electrical devices, on the other hand, may also be tested by trained persons.

This is a clear reference to the expertise required for testing in accordance with DIN VDE 0100-600.

Often, the test results need to be analysed in the context of the specific system to which they relate. This action is what links theory with practice, setting a requirement that only a qualified electrician can meet.


